In consideration of being permitted to participate in a blacksmithing/wood working /wood carving class, I acknowledge that I have been informed of and fully recognize and appreciate the dangers and risks inherent in such activities, and do hereby waive, release and forever discharge JAMES M. SABO, JEEP'S FORGE, LLC AND OTHER INSTRUCTORS and family from and against any and all claims, demands, action or causes of action for costs, expenses or damages to personal property or personal injury, which may result from my participation in these activities.

I understand and admit that my participation in blacksmithing/ wood working/wood carving is voluntary. I assume full responsibility for using reasonable judgment in all phases of participation of the activity and agree to assume responsibility for any and all injuries or damages resulting from my participation in this activity to myself or others taking the class including other classmates and staff. *I recognize and understand that the activities may be hazardous and the hazards may consist of, but are not limited to the following: Injuries to the eyes (flying objects and watching the fire), ears (loud noises), mild-severe burns (sparks, hot metal, fire and coal/fuel), joint/hand pain (repeated motion/blisters), breathing (fine dust/smoke/gas particles) and overheating and/or dehydration (heat/not drinking water) and that I have been adequately warned as to the types of dangers and injuries which may be foreseeable, and that my participation is solely at my own risk, that I assume full responsibility for any resulting injuries and damages and waive any and all claims for damages against the persons or entities listed in paragraph one and agree to indemnify and hold harmless the same with respect to any claims which may be asserted against them arising out of my participation herein.*

All blacksmithing /wood working/wood carving classes *will begin with a safety lesson* followed by a lesson on the *proper use of the tools and equipment* in and around the shop and I agree to abide by all instruction given. A full first aid kit is available on site. I agree to let the instructor know immediately if ANY injury occurs during the class.

Come prepared!

• Wear long sleeve shirt is highly recommended, long pants (non-synthetic) and closed-toe heavy shoes/boots which will protect you from the possibility of a flying embers or sparks. **YOU WILL NOT PARTICIPATE**, If not dressed *appropriately!*

Safety goggles must be worn at all times, ear plugs, aprons, gloves and masks are optional and will be provided along with hand sanitizer.

If NOT feeling well, contact us and do not attend.

If I have any questions, I agree to have them answered before signing this document, and my signature indicates that I feel that everything has been fully explained to me.

I acknowledge that I have read and understand this entire Waiver of Liability and Release, and I agree to be legally bound by it.
